

2011 Premium List Rules

MAKE ALL CHECKS PAYABLE TO **ZONE ONE**. Checks will be deposited promptly -
NO POST DATED CHECKS. There will be a \$50 fee assessed for EACH time a check is returned by the bank.

1. An entry in the Zone One Zone-O-Rama is considered an entry under ALL judges.

2. **Exhibitor Responsibility: SC-160.E** - Exhibitors are responsible for being knowledgeable of and following the current rules, completing entry forms legibly and accurately, reporting to the gate promptly and being considerate of other exhibitors and show management. Additionally, exhibitors, owners and trainers are responsible to be knowledgeable of **Rule SC-085** Drugs and Medications, forbidden and conditionally permitted substances. Conditionally permitted substances require a completed medication report be filed with show office. **Inhumane treatment of animals on the grounds will not be tolerated. Rule SC-075. Proper action WILL be taken.**

3. The Show Secretary or office staff **MUST** inspect the registration papers (or copies of) on each horse entered (except current year foals). Entries shall be made in the name of the recorded owner. Geldings are **not** allowed to show with stallion papers **Rule SC 160.C**.

4. To enter the **broodmare** class, exhibitors **MUST** show a current year APHA broodmare eligibility ID card OR complete an application for an APHA eligibility ID card and return it to the Show Secretary *before* entry in the class.

5. To enter **Amateur** or **Novice Amateur** classes, you **MUST** present a current year APHA Amateur or Novice Amateur card, and own your horse according to **Rule AM 015**.

6. **Novice Youth** must present a current Novice Youth Card from APHA in order to enter any Novice Youth Class, **Rule YP-2051**. **Additionally**, Novice Youth may cross enter into the age appropriate Youth Class. **Youth** must present an AjPHA membership card in order to enter any youth classes (exception being Leadline and Walk/Trot).

7. **All Open Exhibitors must present a current APHA membership card.** The condition of submitting entries or the first entry into the show ring of a horse or exhibitor shall be deemed as acceptance of the *APHA Official Rule Book* and the *Zone One General Rules*.

8. The final right to settle all questions or disputes arising incidentally to the Zone One Zone-O-Rama is reserved to the Show Management. All exhibitors, owners and trainers, as condition of admission, give unqualified consent to such methods of settlement and agree in advance to be bound thereby.

9. Individual class entry registration will close **TWO (2)** classes prior to entry of that class.

10. Show management may combine or split classes according to APHA rules **SC 185.G**, **AM 080.B** and **YP 075.B**. If classes are combined to make an APHA point class, only ONE buckle will be given in the combined class.

11. Anyone withdrawing (scratching) from a class after entering shall forfeit their entry fee in accordance with **RULE SC-185.A**.

12. **Exhibitors/Owners competing for Zone One Awards are responsible for entering the correct classes to qualify for all awards. Award qualifying class lists will be available at the show.**

13. **HIGH POINT ELIGIBILITY:**

ZONE ONE: Junior/Senior/Green Horse Open - All Amateur/Novice Amateur/WalkTrot Amateur - All Youth/Novice Youth/WalkTrot Youth High Points - The Horse must compete in the appropriate halter class (Novice Amateur and Novice Youth must show in Amateur or Youth halter) and in at least three (3) performance classes in a High Point Division to qualify. All classes in each division will count with one rider/one horse combination to apply to all Youth and Amateur High Points.

HIGH POINT SOLID PAINT BRED/BREEDING STOCK:

The horse must compete in one (1) halter and at least two (2) performance classes for Solid Paint Bred.

HIGH POINT YEARLING:

The yearling must compete in Yearling Longeline, Yearling In Hand Trail and the appropriate Yearling Halter Class.

14. **Ties for High Points** will be broken using the following:

1. The horse that earns the most firsts.
2. The horse that places the most times.
3. The flip of a coin.

15. **HIGH POINT & RESERVE HIGH POINT HALTER STALLION, MARE & GELDING AWARDS** will be calculated as follows: Only the Grand and Reserve placings will count. Grand will receive 2 points and Reserve will receive 1 point. Ties will be broken by the most Grands being the winner unless that is also a tie, then the winner of the most Grands and Reserves will receive the award.

16. **HIGH POINT AWARDS WILL NOT BE GIVEN OUT OR AVAILABLE UNTIL ONE (1) HOUR AFTER THE LAST QUALIFYING CLASS. Awards MUST be picked up by the end of the show or be forfeited, unless arrangements are made to deliver awards.**

APHA Awards below will not be final until verified by APHA.

17. **APHA GELDING PLUS:**

- a. Horse owner must be a current member of APHA in good standing.
- b. Owner must reside in Zone One.
- c. Horses are only eligible to win one division per three (3) years.
- d. If horse wins more than one division, the owner is given the choice of which division they wish to receive the honors.
- e. Horse must be a Regular Registry Paint Gelding aged 4 or older, as of January 1, 2011.

18. **Zone One High Point Sculpture** will be awarded to the High Point Solid Bred and Open horse whose owner resides in Zone One and to the High Point Youth and Amateur exhibitors who reside in Zone One.
