Do we have APHA Approval for this years Zone One Show? **Linda Vance is filling it out and will get a check from Linda Wise and get it sent in this week.**

Contract signed with Idaho Horse Park (Has IHP been informed that we will not be back in 2011?) **IHP is waiting for us to get them the stall rates. For 2010 they will be: \$30 per day or \$125 for length of show and \$30 per day for Haul In. This information will be given to IHP**
