OLD BUSINESS:

ZONE ONE SHOW:

- 1. Traci Olney will be doing a futurity night on Friday of the Zone One Show. This event will be in conjunction with the riding futurities and hope to bring back enthusiasm for the futurities both with the exbitors and audience. Appetizers will be served. We will be doing advertising to make people aware of the event.
- 2. Flat fees. All show will be \$450. Division will be \$300. Must be declared ALL or DIVISION when they enter. Does not include NWCC fees.
- 3. Pattern books- Annie Suratt will put together with info aquired form the judges.
- 4. Scribes- Shirly Mann has FFA and judging team that will help with the scribing and gates.
- 5. It was asked of the degates to go back to their clubs and ask if they could help with the show.
- 6. All 6 judges are confirmed. They are: Bruce Army-OH, Michele Pearson-AZ, Marilyn Randall-MT, Tom McBeath-MS, Mark Kuhlwein-AZ and Holly Hover-AZ.
- 7. Stall fees are \$125. for the show, \$35 day fee for a stall and a \$35 haul in fee.
- 8. Advertizing- Annie Suratt is taking care of.
- 9. Show approval- Linda Vance will apply now that all the judges have been confirmed.

10. Awards:

- a. Jackets and Vests. Will cost \$250. for nice quality.
- b. Class Buckles will still be offered. They can choose to take \$75. in script instead. Donations to cover the Buckles and 2nd place script is \$135.
- c. Sheets. sheets for 3-5 place High Point for Division youth and amateur provided though donations.
 - d. Halter High Point plaques. Linda Wise will handle.

- e. Ribbons. For Halter Grand and Reserve, Linda Wise will order.
- 11. Photographer Shane Rex. He will need a motel room.
- 12. Traci Olney discussed the Open Exhibitor Award that she is getting sponsoring for. It will be a high point open exhibitor award (not youth or amatuer) They will need to compete in halter and performance with 2 or more horses. Halter point will be counted by APHA points with grand getting 2 more then the biggest class and reserve getting 1 point. Traci Olney will get the rules and have them posted at the show office.
- 13. A new class list was discussed to go with the new 4 day format.

NEW BUSINESS:

Two members were nominated. Ed Clark and Shannon O'Dell. Voting will be held in December.

BIDS FOR 2014 ZONE ONE SHOW:

Bids were presented from Monroe(Evergreen State Fairgrounds), Albany(Linn Cty Fairgrounds), and Central Point(Jackson Cty expo) After much discssion it was desided to table until a bid could be gotten fron Idaho State Horse Park. It was discussed that there is still much interest in taking it back to Idaho. So Gerry Denning will contact Idaho to get current prices. This will then be brought back to the next meeting for further review.
