- 1. 2021 Zone Show Review:
  - **a.** Class Count Comparison: this was emailed out to everyone to review. The group discussed trends seen over time with classes.
  - b. Show Feedback
    - i. Comment Box:
      - Move leadline to earlier in the day
      - Non-clothing awards
      - Better awards wanted
      - Some Scribes were not dressed appropriately
      - Score sheets not added correctly
      - Gate person was tough to work with for adds and scratches
      - One judge to flag on the exhibitors
      - Weather was too hot can we hold it at a different time of year?
      - Do people come to our show for the awards, or do they come for the point? How much do awards play into attendance?
      - Buckles should be awarded to every class no matter how many people are entered in the class. We had 15 single horse classes for the 2021 show.
  - c. Show Financials: discussed and to be continued at the next meeting. Some of the bills from the show have not yet been paid (buckles and show secretary). Updated financials will be presented at the December meeting.
